



2019-2020 Winneshiek County Fair Queen Rules and Terms of Agreement

1. Contestant must be at least 16 years of age and not more than 21 years of age by the start of the 2019 Iowa State Fair.
2. Contestants must never have been married or have children.
3. Each contestant must be an active member of at least one service organization such as 4-H, FFA, etc.
4. No professional model is allowed to compete in the queen competition.
5. Any contestant that has ran in past years is eligible to run again.
6. All transportation must be arranged by the contestant to and from all required events.
7. All contestants must be present for crowning on Tuesday July 9th at 3:00.
8. All contestants are required to sign up to assist at fair contests and events no matter the outcome of the crowning of queen and princess on Tuesday July 9th (A contestant shirt will be provided to all to wear throughout the week).
9. Each contestant must have an escort for the queen crowning on Tuesday July 9th at 3:00. They must arrive to the fair office by 2:30.
10. The Winneshiek County fair queen must represent us at the 2019 Iowa State Fair Queen competition from 6-10th.
11. The selected Winneshiek County Fair Queen and Princess are expected to give the Winneshiek County Fair Board 100% participation in county and state events as assigned by the royalty director.
12. The Winneshiek County Fair Queen and Princess should not bare another reign or run for a title in any other commodity during their reign. If so, the reign will be forfeited.

I hereby declare that any information stated in my application is the absolute truth. I completely understand that any false information will disqualify me from this and any future Winneshiek County Fair queen competitions.

In addition, if chosen as the Winneshiek County Fair Queen, I agree to attend and participate in the 2019 fair and outside fair events as directed by the fair queen coordinator and Winneshiek County fair board. I also understand I am agreeing to represent Winneshiek County at the 2019 Iowa State Fair.

Lastly, from the application post marked date and in the event that I am crowned queen or princess and during my reign, I agree **NOT** to consume alcohol, drugs or partake in any other illegal actions. I also agree **NOT** to be posting inappropriate social media posts and not be performing any bullying. **THERE IS A ZERO TOLERANCE OF THE ABOVE NOTED RULES.** If the noted things above occur, I will forfeit my reign and crown immediately.
