



2024-2025 Winneshiek County Fair Queen Rules and Terms of Agreement

Contestant must be at least 16 years of age and not more than 21 years of age by the start of the 2024 Winneshiek County Fair.

Contestants must never have been married or have children.

Each contestant must be an active member of at least one service organization such as 4-H, Girl Scouts, Church, or FFA, etc.

Contestant must reside in Winneshiek County or an adjoining county with the majority of her activities in Winneshiek County.

No professional models are allowed to compete in the Queen competition.

Any contestant that has ran in past years is eligible to run again.

All transportation must be arranged by the contestant to and from all required events.

All contestants must be present for crowning on Tuesday July 9th at 3:00pm.

All contestants are required to sign up to assist at fair contests and events no matter the outcome of the crowning of Queen and Princess on Tuesday July 9th (A contestant shirt will be provided to all to wear throughout the week).

Each contestant must have an escort for the Queen crowning on Tuesday July 9th at 3:00pm. They must arrive to the fair office by 2:30pm.

The Winneshiek County Fair Queen must represent us at the 2024 Iowa State Fair Queen competition from August 8-18th.

The selected Winneshiek County Fair Queen and Princess are expected to give the Winneshiek County Fair Board 100% participation in County and State events as assigned by the royalty coordinators.

The Winneshiek County Fair Queen and Princess should not bare another reign or run for a title in any other commodity during their reign. If so, the reign will be forfeited.

Must agree upon all rules of the Iowa State Fair Queen Contest.

I hereby declare that any information stated in my application is the absolute truth. I completely understand that any false information will disqualify me from this and any future Winneshiek County Fair Queen competitions.

In addition, if chosen as the Winneshiek County Fair Queen, I agree to attend and participate in the 2024 Winneshiek County Fair and outside fair events as directed by the Fair Queen Coordinators and the Winneshiek County Fair Board. I also understand that I am agreeing to represent Winneshiek County at the 2024 Iowa State Fair.

Lastly, from the application post mark date and the time I may be crowned Queen or Princess (and the duration of my reign), I agree NOT to consume alcohol, drugs or partake in any other illegal actions. I also agree NOT to post any social media posts deemed inappropriate by the Winneshiek County Fair Board. This also includes any content deemed as bullying. THERE WILL BE ZERO TOLERANCE FOR ANY OF THE ABOVE-MENTIONED ACTIONS. If these noted actions listed above occur, I will forfeit my reign and crown immediately.
